We award grants to about 800 writers each year and support approximately 2,000 events reaching a total audience of nearly 100,000. These events take place in community-based settings ranging from museums and libraries to prisons, senior centers, parks, and hospitals. United States of Writing is a new initiative to extend our service to writers nationwide, especially BIPOC writers and others from historically marginalized groups. United States of Writing focuses on writers in Detroit, Houston, and New Orleans, and will expand to more cities future years.
